- NOTES:**
1. A Club may transfer an athlete on loan to another Club at any time during the athlete's registration period. The beginning and the end of the loan period must be in the same season but eligibility to participate in competitions shall be governed by the provisions note 2 below.
 2. An athlete shall not participate in the same competition with different Clubs in the same season. For the purposes of this Rule, the Waterpolo First and Second Division Leagues and Knock-Outs shall be considered to be one competition. The qualifying tournament for the First Division shall be considered to be a separate competition.
 3. The period during which an athlete is registered on loan shall be considered to be part of his registration period with his original Club.
 4. An athlete may be transferred on loan either for one or for more than one of the disciplines that fall under the aegis of the A.S.A.
 5. A Club may have any number of athletes registered on loan for any one of the disciplines at any one time.
 A registered athlete whose Club is not participating in any age-group Waterpolo competition in which he may participate, has the right to be transferred on loan to another Club free of charge.
 6. Those athletes whose names are not included in the Required Athletes List of a Club and who, during the year in question, shall be at least nineteen years old, shall have the right to be transferred on loan to another Club for the rest of that year.
